Message from the Health Commissioner

2015 was a busy year for the Highland County Health Department. We continue to work through changes brought about by the Affordable Care Act, changes in how insurance is billed, responding to threats from Ebola and Zika, implementing the new requirements from state sewage legislation, and dealing with other issues that have a big impact on how we do business.

Throughout these and other changes, our staff remains committed to improving the community's health. Below are a few highlights from their hard work in 2015.

- Sewage regulations Our Environmental Health Division is working on new statewide sewage regulations that require us to inspect every household sewage system in the county. Our sanitarians are working to incorporate household systems in this program as properties are sold. Kyle Arn, our Director of Environmental Health, recently applied for and was awarded \$297,000.00 in grant funding to allow us to help support residents in covering the cost of system repair.
- Mammography Clinics The Nursing Division partnered with Highland District
 Hospital this year to provide free mammograms to county residents. This
 partnership allowed over 60 residents to receive free mammograms. Ten of these
 residents were referred for more thorough exams based on their screening results.
- New Website Our Administration Division developed a new, more user friendly website in mid 2015. This new site includes an area for new releases, links to program information, and links to our new social media page.

This annual report helps put some numbers to the work of the health department in 2015, but numbers don't tell the whole story of what we do. Numbers won't tell you about the care our nurses put into supporting families with medically handicap children, how they counseled people after being diagnosed with a disease, or how they tracked down and stopped the spread of disease in the community. Numbers won't tell you how closely our sanitarians have worked with local businesses to protect our food supply, how they worked to clean up trash across the county, or the patience they have shown in inspecting every nook and cranny of our schools for safety. Numbers won't show the compassion that people receive when they visit our office for a death certificate, or the joy we share when printing off a child's first birth certificate. Numbers are a good thing, but they only tell a part of our story and our impact on the health of this community.

So, as you read this report, please consider that each number is really a person, a business, or a family that we worked with at the health department in 2015. Much of our work is unseen, and if things go right, you may never know that the health department was there. Whether seen or invisible, our work with the community is part of our ongoing goal to promote, protect, and improve the health of our residents.

Thank you to everyone in the community who continues to support the health department, and thank you to our staff that works every day to make our community a healthier place to live.

2015 Fiscal Report

The Health Department is in sound financial footing, but this year's financial report shows a continuation of a trend started in 2013. For the third straight year, we have spent more than we have taken in. Revenue showed an increase in 2015 of 8%, which is an excellent increase for a single fiscal year. Unfortunately, an increase was also seen in expenses, which were up 12%.

On a three-year average, expenses are increasing at 4.6% annually. Revenue is increasing at 1.4% annually. If this current trend continues, the health department may face financial difficulties as carryover funds are depleted each year. Approximately \$300,000 is needed in carryover funds to get the health department through the first few months of operation each year, until the first tax levy payments become available.

Many cost savings initiatives were undertaken in 2015 by the health department. Below are a few examples.

- Copy/print machine contract was renegotiated for a savings of about \$2,400 annually.
- Epidemiology Contract with Hamilton County was renegotiated from \$7,400 to \$4,200 annually, a savings of \$4,200 annually.
- Bill payment process was adjusted, resulting in savings of about \$1,000.00 in 2015.

Environmental Health Division Report

The Environmental Health Division of the Highland County Health Department is responsible for managing a wide variety of state and local programs designed to promote a healthy environment for Highland County. These services include food inspections, household sewage treatment, private water sources, nuisance complaints (trash, open burning, etc.), environmental disease monitoring, school and institution safety inspections, and many other programs. The following section provides an overview of many of the program areas of our Environmental Health Division.

New sewage regulations require us to eventually inspect every household sewage system in the county. Health Department sanitarians have begun this process, and are working to incorporate household systems in this program as properties are sold. The Environmental Health Division recently applied for and was awarded \$297,000.00 in grant funding to allow us to help repair failing systems that we find in the county.

We are devoted to protecting the environment and the health of the citizens of Highland County. We invite you to stop by our offices or call us anytime that you may have questions or comments. Household Sewage Treatment

A comparison of the number of household sewage treatment systems installed in 2015 and 2014 found a decrease. Eleven less sewage treatment systems were installed in Highland County in 2015 than in 2014. Thirty seven (37) systems including new, replacement, and alterations were inspected and completed this past year, and they were distributed amongst the townships as shown in **Table 1**. This is a **22.9% decrease** in septic system installations from 2014.
